You keep the original check for your own records. We input the information from your faxed check to create a duplicate pre-authorized bank check to deposit, which has the same check number and same amount as the one you fax. After it's deposited for your payment, you will received it back from your bank along with all your other cancelled checks, just as usual.

The security is built-in. Pre-authorized checks have been universally accepted in the banking industry for years. And faxing a check is even safer than mailing it – it is also much faster and far less expensive than overnight delivery. Normal bank return check fee of \$25 dollars apply
